## **Dispatcher's obligations:**

DHD LOGISTICS LLC will perform the following services Monday - Friday 7am to 4pm CST on

behalf of \_\_\_\_\_\_until service is terminated by either party:

- Load searches,
- Booking of loads,
- The paperwork involved in the booking process,
- Carrier packets,
- Check calls with brokers.
- Provide a summary of all loads hauled (Contact details, miles driven, revenue, deadhead miles, and rate per mile).
- The dispatcher agrees to handle all paperwork and calls from the broker to tender commodities shipments to carriers for transportation in interstate commerce by carrier between points and places within the scope of the carrier operating authority.
- **Dispatcher** bears no financial or legal responsibility in the money transaction between the shipper, broker and the **carrier**.
- **Dispatcher** can't contact shippers on the behalf of the carrier.

- **Dispatcher** won't be involved in any money transactions between the shipper, factoring company and the **carrier**.
- **Dispatcher** compensation will be transferred directly from the **carrier**.

## **Carrier obligations:**

- Carrier agrees to pay the dispatcher \_\_\_\_\_\_ of the face value of the contract between the broker and the carrier as stated on the load confirmation sheet (RC). The carrier further agrees to pay the <u>dispatcher on a weekly basis</u> after the invoice of the weekly summary was sent. Failure to comply with weekly invoice terms will result in an immediate additional 5% interest on all late payments.
- **Carrier** gives the **dispatcher** authority to provide his signature for rate confirmations (RC), invoices and any associated paperwork necessary for securing cargo and for the billing purposes as well.
- It is understood that any unpaid services outstanding at the time of termination will be paid within 7 days from the date of the contract termination.
- The terms of this agreement shall be perpetual, provided that either party may terminate the same by giving **30 days** written notice to the other.
- **Carrier** shall be liable for loss, damage or any liability occasioned by the transportation of property arranged by the **dispatcher** while in the possession of the **carrier**.
- **Carrier** agrees to hold the **dispatcher** harmless from any liability for personal injury or property damage occurring during operation conducted by the **carrier** during the time of this signed agreement. **Carrier** agrees that it will function under terms of this agreement strictly as duly permitted contract carrier, and hereby waives any and all rate provisions, which may be contained in its published carrier tariffs.
- **Carrier** will be responsible to comply with all applicable state and federal regulations pertaining to the operation of a motor carrier.
- DHD LOGISTICS LLC invests in training and salaries for all employees. Any attempt to recruit or hire a DHD LOGISTICS LLC employee will result in termination of the service and a fee assessed of \$5,000.
- This agreement is effective on the date that the **carrier** and the **dispatcher** have signed this agreement. If dispute or disagreement arises, both parties agree to tender the issue to binding arbitration in the state of (Georgia).

- This agreement constitutes the entire agreement of the parties hereto and supersedes all prior agreements either written or verbal.
- **Dispatcher** and the **carrier** acknowledge that they have read this Agreement, fully understand it, and have freely and voluntarily entered into it
